# 6) Approval of Overnight Field Trip

Clinton High School Principal and Spanish Teacher, Mr. Hillegonds, is seeking approval from the Board of Education for a student trip to Costa Rica in June 2026. This eight-day, seven-night trip will offer students studying Spanish an immersive cultural and educational experience. The trip will cost approximately \$3,000 per student, covering airfare, lodging, meals, and activities. A \$500 nonrefundable deposit will secure a student's spot, with the remaining balance paid in installments. Mr. Hillegonds has previously led similar trips with Clinton students in 2010, 2012, 2014, 2016, 2018, and 2024, and has extensive experience in organizing these educational travel opportunities. **Motion** that the CCS Board of Education approve the overnight field trip to Costa Rica in June 2026, as recommended by the high school principal and Superintendent.
